**RATES AND CHARGES FOR WATER SERVICE**

- A. **FIXED CHARGE:** A bi-monthly charge based upon meter size:

**RESIDENTIAL CONSUMPTION CHARGE:** A consumption charge, measured in gallons of water, metered bi-monthly, imposed incrementally as indicated below (Summer rates are in effect May 15 – September 14 annually):

Winter – Residential	0-1,496 Gallons	\$0.00/Gallon
Winter – Residential	>1,496 Gallons	\$0.008247/Gallon
Winter – Residential	>18,700 Gallons	\$0.011955/Gallon
Summer – Residential	0-1,496 Gallons	\$0.00/Gallon
Summer - Residential	>1,496 Gallons	\$0.010253/Gallon
Summer – Residential	>18,700 Gallons	\$0.013961/Gallon

- B. **NON-RESIDENTIAL:** Non-residential accounts will be assessed the residential bi-monthly fixed charge based upon meter size. In addition, a consumption charge of \$0.007624/Gallon, up to the customer's average winter bi-monthly usage from the preceding December 1st through May 31st period, will be assessed. Usage in excess of this average (the "Winter Average") during a two-month billing cycle will be billed at \$0.008344/Gallon.
- C. **IRRIGATION:** The bi-monthly meter charge, based upon meter size, plus a consumption charge of \$.013961 per gallon (\$10.44 per ccf).
- D. **FIRE SERVICE** – Non-Residential: A bi-monthly charge based upon line size:

<u>Line Size (Per Inch)</u>	<u>Bi-Monthly Charge</u>
4"	\$ 66.96
6"	\$ 66.96
8"	\$ 66.96

Plus a consumption charge of \$.016635 per gallon.

- E. **FIRE SERVICE** – Residential: A bi-monthly charge of \$8.55, plus a consumption charge of \$.016635 per gallon.

F. **Public School Irrigation** - The residential bi-monthly fixed charge, based upon meter size, plus a consumption charge of \$0.007624/Gallon for consumption up to the customer's average winter bi-monthly use for the preceding period, December 1<sup>st</sup> through May 31<sup>st</sup>, and \$0.008344/Gallon for consumption in excess of the customer's average winter bi-monthly use.

G. **RATES AND CHARGES FOR SANITARY SEWER SERVICE**

(a) **Residential:**

District Basic Charge \$ 69.20 bi-monthly

King County  
Wastewater Treatment –  
Basic Charge \$ 116.28 bi-monthly\* (King County to finalize rate in April 2023)

(b) **Non-Residential:**

District Basic Charge \$ 69.20 bi-monthly  
District Usage Charge \$0.005053/Gallon over 11,220 Gallons in a billing period

King County  
Wastewater Treatment –  
Usage Charge \$0.010362/Gallon

Each amount will be billed separately

(c) Exempt Deduct Meter: \$66.96 bi-monthly.

H. **RATES FOR STREET LIGHTING**

(a) A fixed charge of \$7.50 per billing cycle (bi-monthly)

I. **RESIDENTIAL LOW INCOME DISCOUNT RATE – SEWER & WATER**

**WATER:**

Fixed charge – 50% of the normal bi-monthly charge based on meter size.

Usage – The same as the other residential rates, except that the first 7,480 Gallons are charged at \$.000668

**SEWER:**

District Basic Charge \$ 58.90 bi-monthly

J. **OTHER CHARGES IMPOSED BY RESOLUTION**

Each customer shall pay all other charges imposed by Resolution No. 3744 or other District Resolutions.
